Ray Danyluk, Portage College Board of Governors Chair and Dr. Trent Keough, President was in attendance, along with other representatives of the Board of Governors and staff. Mr. Danyluk and Dr. Keough provided an overview of the College business plan and educational programs. The delegation advised that the Lac La Biche campus serves as the hub for the College.

Mr. Danyluk provided an update with respect to student enrollment statistics and the associated provincial and federal funding for academic upgrading students.

The delegation advised that the College is able to develop programing that reacts to the needs of the community and industry. A discussion ensued on the programs available in St. Paul, Boyle and Cold Lake. Mr. Keough referenced an August 26 interview with the Lac La Biche Post on programs that have departed from the Lac La Biche campus.

A discussion ensued regarding the memorandum of understanding between the County and College for the potable water and wastewater management training as well as the reference testing laboratory.

Mr. Danyluk provided Council with a list of initiatives that are currently being reviewed and revisited by the College. A discussion ensued on the revised model for teaching outreach students.

Acting Mayor Richard thanked the College representatives for attending the meeting.

**RECESS** Acting Mayor Richard recessed the meeting at 2:49 p.m.

**RECONVENE** Acting Mayor Richard reconvened the meeting at 3:00 p.m. with all those Members of Council previously listed in attendance.

### PUBLIC INPUT SESSION/DELEGATIONS/PUBLIC HEARINGS

6.2 Public Hearing – Bylaw 14-003; Amendment to Bylaw 11-010 – Offsite Levies Bylaw;

Acting Mayor Richard declared the public hearing open at 3:00 p.m.

Acting Mayor Richard asked the Manager, Legislative Services whether or not the public hearing was advertised and notice was provided in accordance with the applicable legislation. The Manager, Legislative Services advised that this was the case and that there have been no written submissions submitted in favour or opposed to the proposed bylaw.

Doug Topinka, Manager, Planning & Development Services summarized the purpose for the hearing.

Acting Mayor Richard asked if there was anyone present wishing to speak in favour of proposed Bylaw 14-003. No one came forward.

Acting Mayor Richard asked if there was anyone present wishing to speak in opposition of proposed Bylaw 14-003.

Melvin Bobocel was in attendance and advised that he has concerns with the levies in the current form. Mr. Bobocel read his letter into the record, as attached to and forming part of these minutes. Mr. Bobocel was of the opinion that the County is to act as a facilitator for development.

Roy Worthington, representative of Royal LePage Realty spoke in opposition of the levies. Mr. Worthington advised that he is working with a number of developers and that he is required to provide development cost information to them. Mr. Worthington also noted that the community should work together to attract developers to spend money in Lac La Biche, and that a solution would be for levies to be paid over time. Mr. Worthington was of the opinion that there was a west versus east conflict that he would like to see resolved.

Alex Broadbent spoke in opposition of the levies. Mr. Broadbent listed several other communities that do not impose off site levies, and was of the opinion that developers are being chased away from the County. Mr. Broadbent advised that he is against off-site levies and that general municipal taxes should cover the associated costs. Mr. Broadbent also indicated his annoyance with the method of advertising for the public hearing.

Robert Rizzoli spoke in opposition to the proposed bylaw. Mr. Rizzoli advised that he is against the manner in which the levies are being implemented. Mr. Rizzoli was of the opinion that a fairer model should be developed. Mr. Rizzoli raised concerns that levies imposed would be of a greater value than the developable land(s). As well, Mr. Rizzoli raised concerns on the advertising of the hearing.

Acting Mayor Richard asked if there was anyone else present wishing to speak in opposition of proposed Bylaw 14-003. No one came forward.

Acting Mayor Richard thanked the presenters for their comments and declared the public hearing closed at 3:30 p.m.

#### RE: BYLAW 14-003

Dear Sir/Madam

We are writing this letter in response to your proposed Bylaw 14-003. There are several concerns which we would like to have addressed. They include but may not be limited to the following;

- 1. In your opening statement you are quoted as saying one of the levy charges reflects transportation. Despite this, there are no transportation costs attached to a great many of your proposed schedules (Lakeview Basin, Lac La Biche Basin, Mission Basin, and Plamondon Basin located within the development area).
- 2. In the current plan, there is only one accommodation for Commercial/Industrial, that being identified with a decimal point four (.4). Why is there not proper reflection of this land usage?
- 3. Why are there such huge inequities and levies from one area to the next?
  - a. Lac La Biche Basin substantially cheapest rates, with one exception yet water and sewer has been provided at taxpayer expense.
  - b. Mission and Plamondon Basin show higher levy rates than Lac La Biche Basin, but are substantially less than Lakeview Basin.
  - c. Lakeview Basin consistently highest levy rates. Why is this the case?
- 4. In regard to transportation, sanitation, and water infrastructure. Does the implementation of these levies relieve the Developer of the responsibility of constructing roads, water and sewer on the said Development? Is the County now accepting this responsibility? Please clarify what the Developer receives in return for these levies.
- 5. Paragraph 16 of your Terms and Rates, states that revenue generated by these levies will be invested. What type of investment will be made, and since these are Public

dollars, will the taxpayers have any input as to the types of investments? Who is responsible for potential losses?

- 6. Levies are higher than land value at present market rates.
- 7. Why are levies charged on a "Per Hectare" basis? Such pricing would make large development, such as storage yards, parking lots, etc. prohibitive yet water and sewer usage would be minimal.

In conclusion, it is our contention that your current plan is seriously flawed for many reasons. The most serious repercussion is that these levies will provide further road blocks for potential developers. Council appears to be in a rush to adopt this Bylaw. A very short period of time was allowed for people who will be seriously affected by the Bylaw to contemplate options and provide a response.

In our view, as per previous meetings in regards to Industrial area development, Council seems once again determined to confound development in certain areas despite the clear wishes of potential developers. Inevitably such attitudes will cause potential developers to seek establishing businesses elsewhere.
