### How Does Snow Removal Work in Lac La Biche County? The County's Snow Removal Policy and Procedure

Winter has arrived in Lac La Biche County, and the snow has come with it. Every year, County employees work hard to keep our roads clear and safe to drive, and they have a process in place to do the job as efficiently as they can. Large amounts of snow may affect removal timelines, but the County's goal is to provide consistent snow removal for our residents.

### Thresholds

Snow and ice control measures begin in urban areas after 5 centimetres of snow falls in the business district, and 10 centimetres fall in residential areas.

Snow and ice control begins in rural areas when 5 centimetres accumulates on paved/oil roads, and when 10 centimetres fall on gravel roads.

### Timelines

Snow removal begins within 24 hours on all paved and oiled road surfaces, and within five days on local gravel roads. Full control of snow and ice may take longer depending on the amount of snow and other factors.

### Priorities

Rural:

- 1. Arterial roads.
- 2. Collector roads.
- 3. Local and seasonal roads.
- 4. Fire halls and parking areas.
- 5. Fire department water pick up points.
- 6. County utilities buildings or lift stations.
- 7. Community halls.
- 8. Graveyard access.
- 9. Rural private driveways with snowplow flags.

### Urban:

- 1. Arterial roads.
- 2. Collector roads.
- 3. Local residential roads, seasonal roads, and County properties.
- 4. Back alleys.



### Exceptions

Snow removal takes place during regular business hours and workdays except when:

- Wind and drifting creates problems for traffic movement.
- Roadways have not been cleared in the time period set out in the policy.
- If storm conditions cause priority 1 roadways to become icy or accumulate five centimetres of snow.

Lac La Biche County does not complete snow and ice control on:

- School properties.
- Private driveways in residential and commercial areas.
- Private and oil lease roads.

### Sidewalks

It is the responsibility of residents, institutions, and businesses to adequately remove all snow and ice from adjacent sidewalks.

## Lac La Biche County and the Lakeland Industry and Community Association (LICA) Partner to Install Air Quality Sensor at County Centre

Lac La Biche County has joined a global air quality monitoring network with the installation of a PurpleAir device. Lac La Biche County and LICA – Environmental Stewards (https://lica.ca/) installed the device at County Centre in November.


PurpleAir devices are simple air quality sensors that monitor particulate matter, which may contain pollutants such as dust, soot, or smoke. In the Lac La Biche region, most particulate matter air pollution is emitted directly from sources such as construction sites, unpaved roads, vehicle exhaust, harvest and grain elevator dust, wood smoke, wildfire smoke, and pollen.

Monitoring particulate matter helps us determine the Air Quality Health Index or AQHI, a standardized metric used to report on air quality across Canada (similar to the UV index for sun exposure). By using a simple scale of 1 to 10, the AQHI helps you understand the health risk of air around you: low risk (1-3),



moderate risk (4-6), high risk (7-10) or very high risk (11+). The AQHI also suggests ways to minimize your exposure to poor air quality at each level. Through these PurpleAir devices, there is a network of real-time air quality data across the world. The data from this global network of sensors is displayed on a map, which is accessible to everyone at www.purpleair.com

## Safety Codes: What you Need to Know for Your Next Development

The Safety Codes Act is a provincial document that establishes a framework for the development of safety codes and the delivery of safety codes services for municipalities.

How do they apply to Lac La Biche County residents, developers, or contractors? Several items and permits fall under the *Safety Codes Act*, and we've compiled them here so you can learn more.

Building permits are required for construction, relocation, alteration, addition, repair, or demolition of almost all structures. Depending on the project, you may also be required to provide engineered stamped drawings, which would be part of your application.

In addition, New Home Warranty is a provincial requirement that has been in effect since 2014. It applies to new homes such as single-family dwellings, duplexes, multi-family homes, condominiums, manufactured homes and ready-to-move homes. You can find more information on this by visiting: https://www.alberta.ca/ new-home-warranty.aspx You will be required to provide a copy of your home warranty certification along with your application for a building permit.

Electrical, gas and plumbing permits are required for any work done on your property. A homeowner doing the

work or a certified contractor will be required to complete the application forms.

Private sewage permits are required for any new or upgrades done on systems or the installation of a holding tank. There are specific setbacks and minimum requirements for health, safety and structural sufficiency for private sewage systems and they are regulated through The Alberta Private Sewage Systems Standard of Practice 2015.

The Inspections Group Inc. is the service provider for Lac La Biche County regarding all safety code permits. You can find all the application forms on their website: www.inspectionsgroup.com or by calling (780) 454-5048.
