Re: Public Hearing for Bylaw 13-032

Dear Mayor Langevin and members of Council:

I am writing to provide my comments on Bylaw 13-032, to rezone Part of NW 11, Tp 67, R 13 W4M from Agricultural to Highway Commercial. I will be unable to attend the Public Hearing on Tuesday, October 8, so I will provide my comments in writing.

Although I have some concerns, I am not writing to oppose this rezoning: it makes sense for a number of reasons. It's on the highway (Bypass Road/881), and it's at a good intersection. The County's new Municipal Development Plan (MDP) has identified part of this parcel as an area for Highway Commercial development. The intersection already contains the Corner Gas Esso station, and this is a good location for other highway-related service businesses.

My concern, however, has to do with the natural features in the parcel in question, and how these features are connected to the lands and water features around it. The parcel itself contains a lake (unnamed), as shown in the attachment to the bylaw. This lake is easily visible from the highway, and I have often noticed it when driving past. As shown in the County's Wetland Inventory, the lake is surrounded by a marsh and a shrub fen. A short distance to the west of this lake/wetland lies a treed fen.

The Bylaw attachment also shows a stream channel flowing from the lake, heading northwest, flowing into Claude Lake. It's not clear whether this channel is the main outflow from the unnamed lake, as other references show this unnamed lake to be draining south into another creek. It's possible that it could drain in both directions. At any rate, both routes would carry water from the unnamed lake into and through Claude Lake.

The location of this lake, stream channel and the surrounding wetlands is in the middle of the parcel of land. They roughly form a triangle that splits the parcel into two pieces of high, dry ground on the east and west. I would support any action of Council that would direct development toward these dry land areas, and away from the water-related natural features.

This lake is part of a larger wetland complex, made up of 8 lakes, including Toodles, Leicester, Birkland and Claude lakes, as well as various wetland types, including 11 marshes, 7 bogs, and 23 fens. I have written about this wetland complex recently in another letter dated September 22, for another public hearing, so I won't go into detail here about the wetlands. Suffice it to say that such a rich diversity of water features provides a wealth of habitat for various birds, animals and plant species. And of course, the various other benefits provided by wetlands occur here too: absorbing rain/floodwaters, recharging groundwater aquifers, and helping to purify waters flowing into Lac La Biche.

I'm aware of various policies, from both Lac La Biche County and the Government of Alberta, that reinforce this. As I mentioned in my previous letter, the new Alberta Wetlands Policy and the work in progress by Lac La Biche County on a wetlands policy of its own, both emphasize the value of wetlands to a healthy ecosystem. The County also has a Watershed Management Plan for the Lac La Biche watershed; this Plan rightfully emphasizes the integral connections between land & water. And the newly approved Municipal Development Plan states in several places that the County will try to encourage **sustainable development**. Specifically, it states in Part 9, the goal of trying to "protect natural environmental resources such as lakes, streams, wetlands, riparian areas, and groundwater." Finally, the County was recognized as a municipal leader for its Riparian Setback Matrix Model, a policy that sets buffer zones around water bodies, so that the riparian habitat in these buffer zones is protected.

With these policies in place, you may ask, why am I writing? Why am I concerned? What's the worry? I am concerned because these policies have not always been applied, or they are new or untried, or for one reason or another, they have just not been effective.

I moved to Lac La Biche in 1992. I've learned that over the years, wetlands in this area have been fragmented, modified, drained, filled, built upon, and destroyed. This was considered part of progress, and I'm sure that at the time, they were viewed as acceptable sacrifices. Of course, times change, and we know more now about the value of these water features. Now we are trying to conserve them in their natural state. But we still have enormous pressure for new development projects. So, how do we achieve both: conservation and development?

I am glad for the work on wetland conservation that the County and the Province have started; I would like to see results. I am glad for the County's riparian policy, but I don't know how often it has been applied, and I get the impression it's not applied as often as it should be. I am glad for provincial water legislation, and that all water bodies, to the bed and shore, are the property of the Crown, and I'm glad that sometimes, this serves to protect water bodies adequately, but too often it doesn't. I'm glad that the MDP states the goals of sustainable development and protecting our valuable natural features. But it doesn't always achieve this. Protection is balanced with development. All too often, developments are approved, and nature is sacrificed. When I first learned about the County's Watershed Management Plan, I was impressed. The County was being proactive, I thought, about ensuring a healthy watershed, healthy lakes, healthy ecosystems. Any activity on land has an impact on the adjacent water systems, this is obvious. It looked to me like the County recognized this, and took it to heart. I knew that municipalities can accomplish a great deal of conservation goals through their functions of land-use planning, and development approvals. I had great hopes for this policy to get results, to make a difference.

I realize that my expectations were unrealistic; call it high hopes, or wishful thinking. A watershed plan, or a municipal development plan, or a riparian setback policy, can't achieve these goals. I see it depends on the decisions of Council. The support of the community can help, but ultimately it's Council that decides what stays and what goes.

Recently I learned that Lac La Biche was hosting a gathering of Development Officers from across the province, and that one of the guest speakers was Avi Friedman, a Professor of Architecture at McGill University. Again, I was impressed. I asked about what said, and I learned that, among other things, he spoke about various environmental ideas in the planning and development process, such as building green, limiting urban sprawl, etc.

I would have enjoyed hearing him. I'm sure he would have noted that here in Lac La Biche County, with our wealth of wetlands, many of them still intact, we have an opportunity to avoid the path of many larger urban areas, where these features were destroyed years ago, in the name of progress, and where now, many of them are spending enormous amounts of money to restore them to more natural conditions.

You as County Councillors can help us avoid this unsustainable path. You have these various useful tools at your disposal, and you have the power to use them. My requests to you are:

- I ask that you recognize this unnamed lake as a permanent and naturally occurring water body (under Section 3 of the Public Lands Act,) and require any development proposal to leave sufficient buffers to protect the rich riparian habitat around the lake.
- I ask that you identify the stream channels that connect it to the surrounding wetland complex, and require similar buffers along this stream, to maintain or improve the wetland ecosystems.
- I ask that the County and the Alberta government together identify the marshes and fens that surround the lake, and protect the riparian habitat they contain.
- I ask that you confirm that the County's riparian setback policy will be applied when a development proposal is made. The policy, applied in a manner that is fair and reasonable, would help to ensure, as stated in the MDP, "that all new development is carried out in a way that minimizes negative impacts on rivers, streams, lakes, wetlands, riparian areas, forests and groundwater."
- I ask that you make the developer aware of these considerations, for use in preparing any development plans, and that the Planning and Development Department staff also be reminded of them when any development application is made.

This parcel, with its combination of dry land along a highway at a desirable location, and a rich diversity of wetlands and water bodies adjacent to it, offers an opportunity to strike a healthy balance and make a step toward sustainable development. I hope you will agree. Thank you for your consideration of my comments.
