- The draft Economic Development Plan will be presented to Council at the March 5, 2013 Policy and Priority Committee Meeting;
- The Economic Development department is working on marketing and networking materials to attract retailers to the region. This includes, but is not limited to a website update and a social media plan; and
- The Economic Development department is working on research projects including mapping, demographics, land value and mill rates.

Roy Brideau, Chief Administrative Officer reported that he has a meeting scheduled with the Assistant Deputy Minister (ADM) of Municipal Affairs. Mr. Brideau provided Council with the following items for discussion with the ADM:

- Expansion urban centres of County;

- Review of MGA how can Lac La Biche County participate?;
- Long term Municipal Sustainability Initiative (MSI) strategy;
- Regional government designation vs. County/Municipal District;
- Affordable housing; and
- Financial assessment/349 and four townships (caribou lands).

A discussion ensued on each topic, and Members of Council did not recommend additional matters for discussion.

Mr. Brideau reported that Administration is working on developing a work-plan for 2013 and that Council will receive updates every two months.

Mr. Brideau notified all those present that he currently has a list of twentyfive items for discussion at future Strategic Sessions. It was noted that adhoc sessions will be required.

- Update regarding dialysis & CT Scanner.
