Mayor Moghrabi asked if there was anyone present wishing to speak in support of or in opposition to the proposed bylaw.

Mr. Albert Stratichuk, adjacent landowner of Madison Meadows Park, noted he is in favour of the proposed rezoning and expressed his frustration with this particular area not having the proper infrastructure to allow a sufficient water supply and water pressure for future development. In Mr. Stratichuk's opinion, the County should upgrade the water lines to a twelve-inch line to accommodate future development on the land adjacent to the intersection of Highway 36 and 55.

Ms. Fatima Tarrabain, on behalf of her mother, Mrs. Tarrabain, is in favour of the proposed rezoning and is of the opinion that if the property is rezoned from Urban Reserve District to Highway Commercial District that the property would be more viable and would provide more options for future development.

Mr. Shaw confirmed there were no letters submitted in support of or in opposition to the proposed rezoning Bylaw 17-012.

Mayor Moghrabi asked if there were any closing comments.

Mr. Shaw stated that the proposed rezoning of the said property is conducive to what is currently in the area.
