
Development and Cost Sharing



Development Costs

- Infrastructure costs directly related to the Development are the responsibility of the Developer:
 - New infrastructure in the Development Area
 - Upsizing or new offsite Infrastructure
- Costs include design and construction
- The County will be responsible for operation and maintenance

Offsite Infrastructure - Example



Offsite Infrastructure

- There are two options to pay for the lift station:
 - The County will pay for it upfront and charge the developers through **Off-Site Levies**
 - The first developer will upfront the total cost of it and will get reimbursed when future benefiting areas are developed (Endeavour to Assist)

Off-Site Levies

- Capital Cost Recovery Tool
- Section 648, 650 and 655 of the MGA
- Off-site levies may be used <u>only</u> to pay for all or part of the capital cost of new or expanded infrastructure
- Water, Sanitary, Storm, Transportation and Land
- County will develop and pass the Off-Site Levy bylaw

Off-Site Levies - Process

- Growth/Development Plan for the County
- Identify
 - objective of the levy (water, sanitary, transportation...)
 - infrastructure requirements for development
 - benefitting area
- Developers charged at the time of development
- Payment can be a condition of Subdivision (through Development Agreement) or Development Permit

Endeavour to Assist

- Capital Cost Recovery Tool
- Section 651 of the Municipal Government Act (MGA)
- Enables the Municipality to Facilitate Infrastructure Capacity for Future
 Developments
- A Legal Document / Agreement
- Implemented at the Subdivision Approval or Development Permit Stage
- In addition to infrastructure required for their development, the Developer pays for upsizing (excess capacity beyond their needs)
- Municipality will 'endeavour to assist' the Developer in getting reimbursed (initial investment plus interest) when Future Development Occurs

Endeavour to Assist - Process

- Identify the infrastructure/facilities needing oversizing
- Identify the benefitting areas
- Determine "Excess Capacity" more than what the developer needs to service their land
- Enter into an Agreement repayment period, interest rate
- Municipality will require payment by subsequent developers in benefitting areas at Subdivision or Development Permit
- The initial Developer will get paid if development occurs

Considerations

- Endeavour to Assist and Off-Site Levies are tools for municipal capital cost recovery
- Municipality can use both methods at the same time
- Avoid "one size fits all" approach
- Develop a clear methodology for calculation of excess capacity, costs and benefitting areas (Growth plans, Master Servicing Plans)

Considerations

- □ Use professional assistance
- Update periodically
- Be Consistent Methodology is consistent across the municipality while recognizing the variation between infrastructure types and needs
- Be Transparent Make all the referencing and supporting documents available

Considerations

- □ Communicate and Engage
 - Council
 - Development Community
 - Administration

Selecting a Method

- Be mindful of "Risks" associated with each
 - Balance between financial risk and encouraging development and investment
 - Fairness
 - Benefit to Community
 - Responsible allocation of municipality's revenue (taxes)
- Council Support and Direction is necessary for selecting the tool and implementing it successfully
