Remember to check for hot spots at winter burn sites



Double checking your winter burn sites is an important wildfire prevention step.

Winter burn fires are also referred to as "Zombie fires" because they can come back to life in the spring when hot embers deep inside the burn site are renewed by warmer temperatures and wind.

Wildfire hazard conditions are usually their highest in spring before rains arrive and foliage begins to green up.

Prior to spring you may contact Fire Services at 780-623-6774 to schedule a free assessment of your burn site with a Thermal Imaging Camera (TIC) to check for hot spots.

Preparing for the driest time of the year each spring is important to reducing the overall risk of wildfire.

Agricultural Burning Tips

If you have a fire permit follow the directions on it. Doing so will help ensure you are taking necessary precautions and appropriate safety measures are in place. Lac La Biche County follows Alberta Agriculture and Forestry's hazard restrictions when issuing burn permits.

Monitor your burn; don't leave your field while it's burning. Burn small areas at a time and have a plan to deal with any emergencies.

Have a water truck and other equipment on hand. Till the outside borders of the field to create a fire break. Monitor the site after your burn and check for hot spots that may remain.

Consider reducing the scale of the burn by baling the un-harvested crop or straw, and removing it from the field. Burn the bales away from your field in a smaller, controlled area. This is easier to monitor and manage than burning swaths in a field.

Lastly, make sure you have sufficient property insurance in the event that your fire gets out of control, or spreads to neighboring land. If you are found responsible for starting a wildfire, you can be charged under the Forest and Prairie Protection Act.

Costs associated with non-negligent incidents are covered by the County. Call 9-1-1 for all emergencies.

Fire Permit Season

To protect the community and the environment, permits are required for all burning (besides campfires) from March 1 to October 31.

Permits are free but site inspections are required, and permits may be conditional to ensure safety for everyone.

Changes implemented with Complaint Line

Residents who call the Lac La Biche County Complaint Line will notice some changes to the way the system works.

After dialling 780-623-6767 an initial recording will be played before switching to hold music. While the music is being played the Complaint Line system is automatically contacting all available, on-duty Peace Officers.

If no officer picks up the call and you are prompted to leave a message, it is because all available officers are dealing with an emergency or complaint.

Please be sure to leave a voicemail message so Peace Officers can return your call as soon as possible.

"We want to assure residents that all calls made to the Complaint Line will be followed-up by our department," says Chris Clark, Enforcement Services Manager. "As a reminder to residents, if your call is urgent and requires a police response 9-1-1 should be called."

Lac La Biche County employs 11 Peace Officers and the Enforcement Services department works in partnership with local RCMP to provide services to residents of Lac La Biche County.

Home improvements & permits

Did you know you may need additional permits to finish your basement project?

If you are renovating by creating or removing walls and/or rooms, the applicable safety code permits will be required and can be obtained through The Inspections Group Inc. website: https://www.inspectionsgroup.com/

If you are looking at creating a secondary suite or rental suite, a development permit and applicable safety code permits will be required.

A secondary suite is defined in the County's Land Use Bylaw (No. 17-004) as a self-contained accessory dwelling unit that is located within or on the same lot as an existing single detached dwelling. It has food preparation, sleeping and bathing facilities, which are separate from those of the principal dwelling.

A secondary suite also has an entrance separate from the entrance to the principal dwelling, either from a common indoor landing or directly from the exterior of the structure.

Typical uses include basement suites, garden suites, granny suites and garage suites.

Section C2.26 of the Land Use Bylaw regulates the following for secondary suites:

- 1) Maximum of one (1) secondary suite may be permitted on a lot.
- 2) A secondary suite shall be limited to a maximum of two (2) bedrooms.
- 3) All secondary suites shall comply with the requirements of the Alberta Safety Codes Act or its successor.

Table C2.4 of the Land Use Bylaw also regulates setbacks, suite size and height for secondary suites.

Fire Smart Assessments

Lac La Biche Protective Services can help add another layer of protection to your property by conducting a free Fire Smart assessment.

Trained inspectors look at rural properties that have direct interface with the forest and recommend ways to reduce the danger of a wildfire starting and spreading on it. The recommendations are based on a Wildland-Urban Interface Plan that analyzes hazard risk levels and identifies areas of concern.

Free FireSmart assessments can be requested online by visiting <u>laclabichecounty.com/protective-services</u> and submitting an electronic request form.

To help deal with woody debris, the Fire

Smart program also offers free wood chipping for residents of Lac La Blche County.
