Watershed Management Plan being updated

Lac La Biche County is updating the Lac La Biche Watershed Management Plan (WMP) to replace the previous WMP from 2009. Throughout 2020, the County and the WMP Steering Committee have been preparing a draft WMP.

What is the WMP?

The WMP is a comprehensive, science-based plan that will coordinate action for the protection and improvement of Lac La Biche, its shore lands, and watershed. It is a guidance document and planning tool primarily for decision makers (municipalities and local authorities), non-governmental and community organizations, industry, and watershed residents. The WMP will establish goals, objectives, and recommendations that aim to help protect the watershed and the lake. The WMP identifies three geographic areas where these recommendations can take place: **The Watershed Lands, The Shoreline, and The Lake.** The recommendations for these areas will address topics such as land cover, biodiversity, land use, phosphorus management, water quality, and riparian areas.

What's Next?

In the coming months, the draft WMP will be posted on the Lac La Biche County website and there will be online public engagement sessions to learn more about the WMP. Watch for

Fire Services recruiting for all stations

Paid-on-call firefighters operate in five districts

Lac La Biche County Fire Services is looking for everyday heroes to join the ranks across the region. They have stations across the County in Owl River, Hylo, Rich Lake, Plamondon, and Lac La Biche.

Did you know?

- Fire Services currently has 63 members, including full-time administrative staff.
- Fire Services had 467 calls in 2020. Approximately \$3.9 million in property was saved due to structural firefighting response.
- The department completed 90 FireSmart home assessments, and conducted wood chipping on 65 properties. Staff also performed Fire Smart prescriptions on Blais Resort across 3.7 hectares, which reduces the likelihood of wildfires threatening homes and properties in that area.
- Staff completed 39 Safety Codes Fire Inspections in 2020.
- One firefighter recruit class was held in 2020 with 10 successful students (7 probationary firefighters and 3 cadets).
- In the June 2020 flood, firefighters were instrumental in not only assisting to pump water out of flooded areas but also in providing rescue services for residents




In 2021, a new 20,000 square foot firehall will be operational as the Regional Fire Services facility housing headquarters, Station #1 staff, and apparatus. This building will enhance operational response and training, including our annual recruit classes.

In addition to 40 hours of training, new cadets and recruits will have knowledge in hazardous materials, vehicle extrication, ladder work, breathing apparatus, ropes and knots, protective equipment, water supply and WHMIS, in addition to several other vital areas.

Council approves waiving Fire Inspection/Occupancy Load Limit Fee

To help local businesses comply with the requirement for occupancy load permits (legal number of customers permitted at one time) during the COVID-19 pandemic, Council has approved waiving the permit fee (\$125) retroactively in effect Jan. 1 through to Apr. 1, 2021.

Temporary occupancy load permits for businesses/organizations are required due to the Province's COVID-19 regulations. This permit legally determines how many customers are permitted to enter a business at one time and is processed through Lac La Biche County Fire Rescue Services
