## **PUBLIC HEARING (Continued)**

Mr. Owen Yadlowsky, son of the applicants, Mr. Ken & Lina Yadlowsky, continued his presentation to Council. Mr. Yadlowsky stated he is in favour of the proposed bylaws citing they wanted to improve the property and community by subdividing the property to ensure the residential portion is outside the 300 meter landfill buffer zone, and to utilize the two properties that are within the landfill buffer zone for commercial purposes.

Mayor Moghrabi asked if there were any written submissions or registered speakers in favour of the proposed bylaw; there were no additional registered speakers but there was one written submission from Mr. Randy Wowk, on behalf of 1253591 Alberta Ltd., who was in favour of encouraging commercial activity in the area, but he had concerns regarding rezoning compliance; the submission was read into record by Ms. McConnell.

Mayor Moghrabi asked if there were any written submissions or registered speakers in opposition of the proposed bylaw; there were no registered speakers, but there was one written submission from Ms. Joanne Blanchette. The submission opposed the rezoning citing property devaluation and noise impacts; the submission was read into record by Ms. McConnell.

Due to technical issues, Councillor Moore was not in full attendance during the course of the Public Hearing.
