



LAC LA BICHE MAIN STREET REVITALIZATION



CONSTRUCTION NOTICE REVISED

Main Street, between 101 Street and 102 Street, is intended to be closed for construction on **Tuesday, April 23rd until approximately October 31st, 2024.**

In **Stage 1**, 100 Street, north of 101 Avenue is tentatively planned to be closed for installations **between Thursday, May 2nd and Monday May 6th, 2024.**

In **Stage 2**, from **Tuesday, May 7th to October 31st, 2024**, the 101 Street and 101 Avenue intersection will be closed, once 100 Street has reopened.

Please be aware that all construction is weather dependent. During construction, there will be modified pedestrian access and limited vehicular access. Signage for road closures and detours will be set up to direct traffic from all directions.

Impact to Residents and Local Traffic:

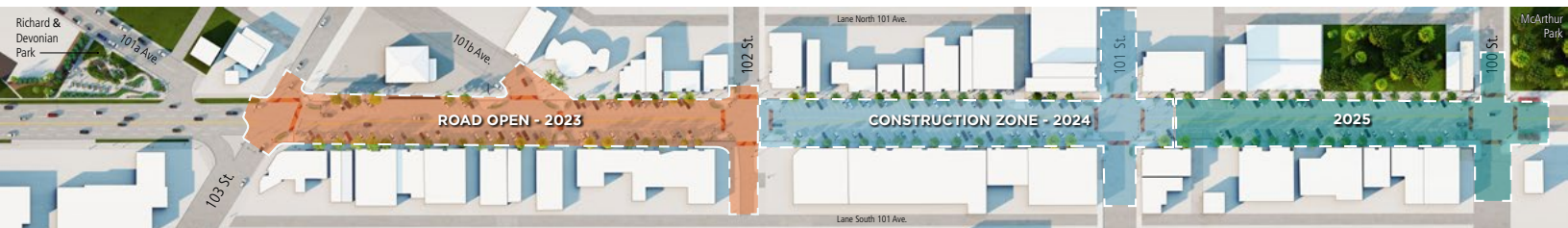
- Noise and presence of construction equipment/traffic.
- Curbside collection will not be affected. Place containers in their normal location.
- Temporary water services will be provided to affected residents and businesses. Residents are asked not to tamper with temporary water line, valves, or fittings.
- Several short-term water service interruptions will be required. Residents and business owners will be kept updated as to when these will occur.

Residents are asked to please respect all construction signage, fencing, and barricades. We ask that the public stay clear of this area.

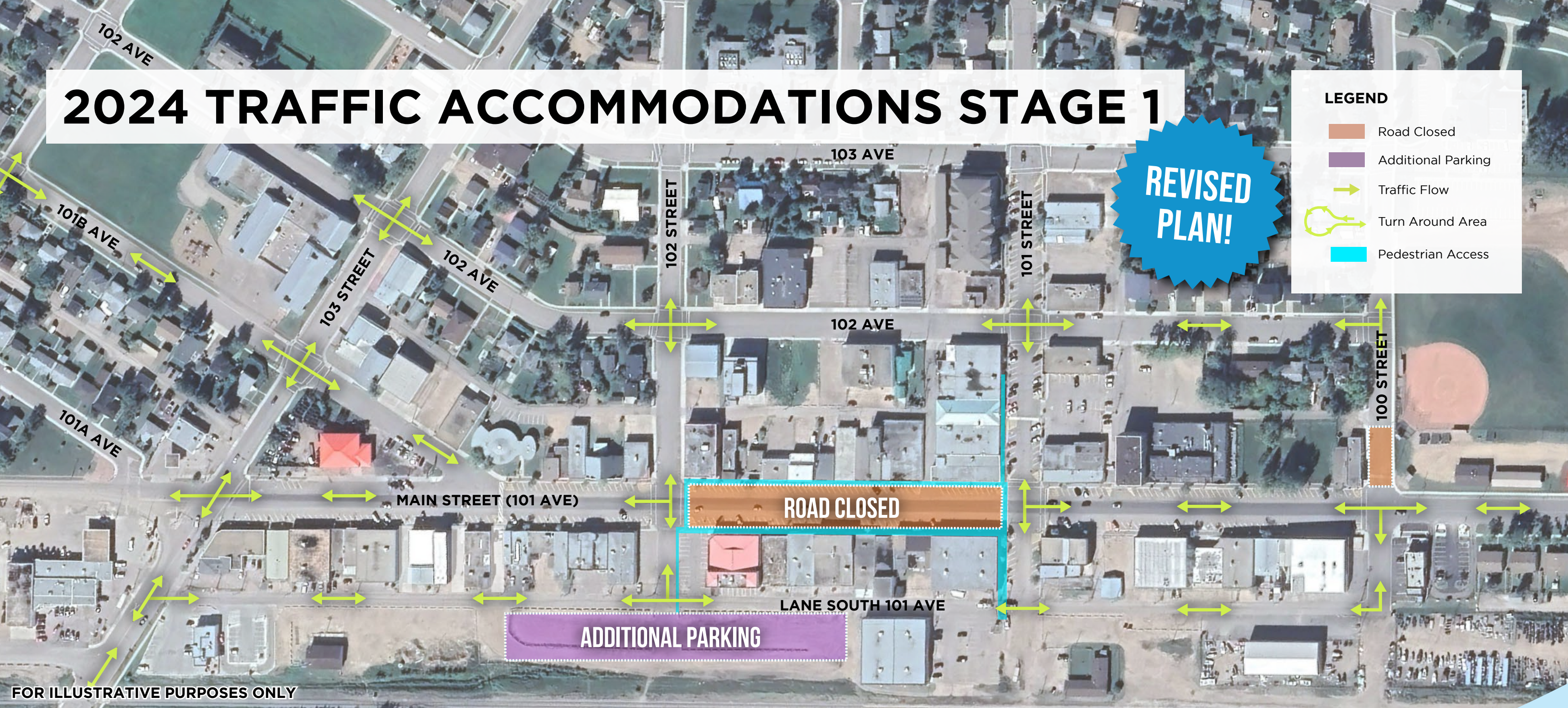

Access to businesses will be maintained throughout the project.



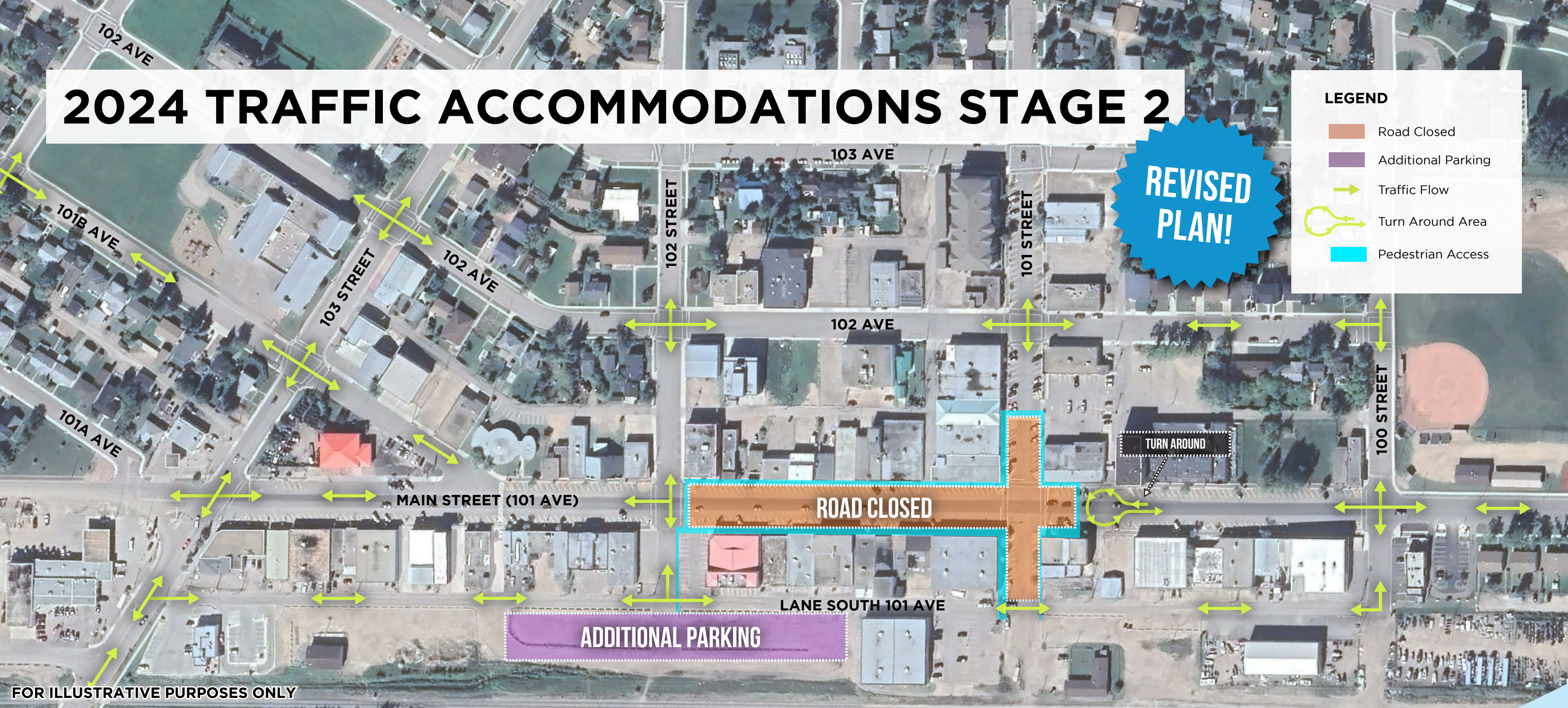
