NEW BUSINESS

3.1 Land Use Bylaw Review.

Dave McRae, Representative of ISL Engineering and Land Services, was in attendance and presented a PowerPoint presentation which reviewed the current Land Use Bylaw and stated the reasons for the required update and proposed changes of the same.

The sections of the current Land Use Bylaw presently under review are as follows:

- Land Use Districts – clarification was provided in areas, certain districts were deleted and others combined, new districts were created;
- Overlays: Airport Vicinity; Historical Resources; and Riparian Area Protection;
- General Regulations – regulations updated and new ones added;
- Special Land Use Regulations – regulations updated and new ones added;
- Aggregate/Peat Extraction – clarification provided and provisions added;
- Campgrounds – discretionary and permitted uses revised and definitions broadened;
- RV Storage – regulation expanded;
- Work Camps – regulation expanded and clarified;
- Other regulations such as Parking and Loading, Landscaping Standards, and Signage; and
- Administrative provisions – Updated and Clarified.
