We are pleased to announce the commencement of the Highway 881 Approach Upgrade project at Beaver Hill Road. This project aims to enhance roadway conditions, improve safety, and address drainage issues.

Timeline: July 15, 2025, to August 25, 2025 (As per Weather Conditions)

Scope of Work: Grading, Base Paving and Other Work -

Including excavation, removal of existing asphalt pavement, subgrade preparation, installation of granular base course, asphalt concrete paving, culvert installation, fencing improvements, topsoil placement, seeding,

and pavement markings.

Hours of Work: 7:00 a.m. to 7:00 p.m. (Monday to Saturday)

9:00 a.m. to 7:00 p.m. (Sunday and Holidays)

Impact to Residents and Local Traffic:

- Minor delays and temporary traffic interruptions are expected.
- Construction signs and safety messages will be installed before work begins and monitored continuously during the project.
- Safety conditions will be regularly monitored, with dust control measures implemented as needed.
- Flagpersons will be provided as required to ensure traffic and pedestrian safety.

Special Instructions for Residents and local traffic:

Please be mindful of all installed construction signage and safety messages. Maintain a safe distance from construction work and do not enter marked, flagged or barricaded areas. Always follow traffic directions from all crew personnel during construction operations.










The general location and work area is attached. Construction signs, and/or safety messages will also be installed.
