URGENT MATTERS

5.0 Fort McMurray Evacuation Update.

Mr. John Kokotilo, Manager of Protective Services (Fire/Enhancement), provided an overview of the events that transpired to have the Bold Center become an evacuee reception centre.

Mr. Kokotilo provided the following information regarding recent events:

- 4,730 evacuees have registered at the Bold Center;
- Several animals have been taken in by the Lac La Biche Regional Humane Society housed in the Bold Center;
- There are over 250 volunteers;
- Beaver Lake, Plamondon, Kikino, Wandering River, Boyle, Grassland, and White Sands have assisted the Bold Center with taking in evacuees;

- With regard to supplies the Plamondon arena is full, the old salt shed is full, the new salt shed is full there is a need for fresh meat and produce;
- Utilities will be starting their inspection and rebuild in Fort McMurray in two weeks;
- It is estimated that 20% of Fort McMurray burned, leaving approximately 20,000 people affected;
- The Province deems specific areas as reception areas; if Lac La Biche County runs out of room, the Province can set up a new reception area;
- Inventory on occupancy rates is shared with the Provincial Operations Centre (POC) three times per shift;
- Many staff volunteers are working 12 hour shifts;
- There are 269 evacuees currently being housed at the Bold Center, with 770 cots available in total;
- Waiting on the Provincial Government to get the evacuees off of the cots and into beds within seven days.

Ms. Shadia Amblie, Chief Administrative Officer, advised that time will be added to Bold Center memberships to compensate for lost time due to the Bold Center becoming a reception center.

- What Community Futures is and how they support rural communities;
- Community Futures does not give grants, they lend;
- Since 1986 Community Futures has invested over \$50 million in small business loans;

- Goal is to help businesses expand, grow and succeed;
- Provided funding facts for 2015-16, reviewed their Loan Portfolio and success rates.

Ms. Jaclyn Denman, Community Economic Development Coordinator for Community Futures Lac La Biche, provided an overview of the Lac La Biche Region Discovery Guide (the Guide). The following information was provided in Ms. Denman's presentation:

- The Guide is a 48 page publication promoting accommodations; festivals and events; restaurants; Hamlets, Reserves and Metis Settlements in the County; things to do and see such as trails, Farmers' Markets, fishing, etc.;
- 20,000 copies of the Guide are made and distributed every year;
- Guides distributed to date: 6,000 to trade shows, 4,000 to local businesses and campsites, 25 mailed out, and 5,000 mailed out to visitor information centers;
- The Lac La Biche Region is gaining awareness through the <u>www.laclabicheregion.com</u> website and through social media such as Facebook, Twitter and Instagram;
- Review of opportunities and challenges of marketing the Lac La Biche Region;
- Community Futures Lac La Biche loaned 10% of the whole dollars loaned in the Province.

- Expected attendance 300–650 Archers, plus Coaches, Managers, and Translators; 25 45 countries;
- 3D Worlds are held every two years;
- Lakeland Archers entered a bid to have the 2017 Indoor 3D Nationals in Lac La Biche to be held April 14 – 16, 2017;

Mayor Moghrabi entered Council Chambers at 11:30 a.m. Deputy Mayor Nowak continued to Chair the meeting.

- Expected attendance 300–400 Archers and families from all over Canada for three days;
- Lakeland Archers will be notified on July 30, 2016 if they were the successful bidders

Mr. Stein would like the County to expedite permits, waive any permit fees and taxes, and grant access to water and sewer services.
