6.2 Delegation – Dr. Richard Birkill – Chief of Staff at William J. Cadzow Health Centre;

Dr. Richard Birkill was present and provided an update on medical services for the Lac La Biche County and discussed the following information:

- Staffing shortages and new recruitments;
- New bathtub for continuing care has been received and is awaiting installation by Alberta Health Services (AHS);

- New monitors for Acute Care have been approved, and are awaiting installation by AHS;
- General surgeon resigned, completed a business case to present to AHS, requesting a full-time surgeon;
- Discussed urgent need for a general surgeon and diagnostic services such as a CT scanner and Ultrasound;
- Shortage of ultrasound technicians due to private industry;
- Discussed signing bonuses and other options to encourage technicians and surgeons to work in our community;
- In order to attract a general surgeon to the area, a diagnostic center is required that would include a CT scanner and Ultrasound equipment, hence the urgency of obtaining the same;
- Have a technician willing to move to Lac La Biche, need an additional \$25,000 to supplement her income;
- Discussed the need for more beds in the William J. Cadzow Health Centre if and when more services are being offered;
- Too costly to transfer patients out to other facilities to receive CT scans and Ultrasounds;
- There is a sense of urgency in getting a diagnostic centre in Lac La Biche as there is only a small window of time left before the door closes for this opportunity;
- The cost of diagnostic imaging equipment would be 1.5 million dollars, the space is available at the Health Centre with minor renovations required, but AHS would have to agree to pay for the maintenance of the equipment;
- Received letters of support from Boyle and Athabasca Health facilities to have Lac La Biche become the HUB for area 7;
- Could have a full-time surgeon here by July, would be ideal to tell the surgeon that we have diagnostic services coming;
- What is required to make this possible is a CT scanner, an ultrasound and CT technician, and a commitment from AHS for maintenance;
- Discussed community and Health Foundation donations;
- Discussed dialysis services and what would be required to move the service into the Health Centre.

Dr. Birkill thanked Council for their time and Mayor Moghrabi thanked Dr. Birkill for his presentation.
