





NOTICE OF CONSTRUCTION UPDATE

CAMPSITE ROAD - GRANULAR BASE COURSE, ASPHALT CONCRETE PAVEMENT AND OTHER WORKS

Dear Property Owners/Residents:

Lac La Biche County is committed to enhancing our infrastructure. We are pleased to announce the commencement of the Campsite Road Improvement project. This essential work will involve upgrading a significant section of the Campsite Road to improve safety, drainage, and overall road quality.

Timeline: June 19, 2025, to September 30, 2025 (Weather Permitting)

Scope of Work: The project includes granular base course application, asphalt concrete pavement, ditch improvements, culvert removal and installation, approach improvements, seeding, pavement markings, flexible guideposts, and removal/salvage of existing signs.

Hours of Work: 7:00am to 7:00pm (Mondays to Saturday)

9:00am to 6:00pm (Sundays and Holidays)

Large trucks will be hauling material from the existing construction site to the stockpile site along Campsite Road and predetermined haul routes.

A map of the general location and work area is attached. Construction signs, and/or safety messages will also be installed.

Knelson Gravel & Sands Ltd. will work diligently and effectively to keep the public safe as a top priority and complete the work within schedule.

Impact to Residents and Local Traffic:

- Construction activities might cause minimal disruption to the public traffic. To complete this
 work lane closures will be required. However, one open lane will be always maintained so
 that traffic can travel through the work zone.
- Heavy equipment and truck traffic moving in to and out of the work site.
- Residents and passing traffic are advised to be cautious of the heavy equipment working at the site.
- A dedicated site person may be assigned to guide the public and traffic, as required.
- Garbage pick-up will continue normally, and we ask you that you bring your garbage to the end of your driveway to ensure pick up is not missed
- Signs and safety messages will be installed prior to the start of construction and will be monitored throughout the construction period. Safety will be monitored, and dust control will be addressed during construction.







Special Instructions for Residents and local traffic:

Please be mindful of all installed construction signage and safety messages. Maintain a safe distance from construction work and do not enter marked, flagged or barricaded areas. Always follow traffic directions from all crew personnel during construction operations. It is important to note that there will be a time gap between completion of the gravel base and paving operations. We currently anticipate having all asphalt paving completed towards the end of the project. For questions/clarifications regarding the limits of paving for driveways, please call Kunal Chander.


