6.1 11:00 a.m. Public Hearing - Bylaws 20-033 Lac La Biche Airport Area Structure Plan (ASP) and 20-034 Airport District (A) Land Use Bylaw Amendment Public Hearing

Mayor Moghrabi declared the Public Hearing open at 11:05 a.m.

Mayor Moghrabi asked Ms. Melanie McConnell, Associate CAO-Corporate Services Division whether or not the public hearing was advertised and notice was provided in accordance with the applicable legislation. Ms. McConnell advised that this was the case.

Ms. Sheera Bourassa, Planning and Development Officer, summarized the purpose for the hearing.

Mayor Moghrabi asked if there were any registered speakers in support of the proposed bylaws; there were no registered speakers. Mayor Moghrabi asked if there were any written submissions in favour of the proposed bylaws; there were two written submissions read into record by Ms. McConnell. The first submission was from Mr. Brian Deheer – the submission requested correction to the identification of a wetland, consideration of the Natural Wetland Area provision to two wetland areas in the area structure plan and clarification on the impacts of the airport expansion on a wetland identified in the plan. The second submission was from Mr. Ken Zachkewich – the submission encouraged the County to consult with the federal government as it relates to compliance with the aeronautics acts.

Mayor Moghrabi asked if there were any written submissions in opposition of the proposed bylaws; there were none. Mayor Moghrabi asked if there were any registered speakers opposed to the proposed bylaws; there were two registered speakers. Mr. Matthew Umble spoke first and advised he was not necessarily opposed but had sought clarification related to Bylaw 20-034 section 3 parking/loading/storage/garbage collection and noted he received the requested information from planning and development and felt that his question had been addressed. Mr. Trevor Funk spoke second and advised that he was a landowner in an area identified for potential future development and noted he was not necessarily opposed to the plan but wanted additional information about the potential impacts to his land and options he may have as a landowner related to the future development potential.

Mayor Moghrabi asked if the Applicant wished to make any closing comments. The Applicant (Lac La Biche County) advised that an amendment was planned for the wetland correction requested in the written submission. Planning spoke with Mr. Umble and clarified the requirements to the Land Use Bylaw to future developments.

Mayor Moghrabi thanked the presenters for their comments, and declared the Public Hearing closed at 11:20 a.m.
