New business crime prevention program launched

The Business Partnership Program works to enhance crime prevention strategies and reduce property and business-related crime in the Hamlet of Lac La Biche.

Once an agreement is signed and submitted to the County, Peace Officers are given the authority to act as "agents" for the property or business owner.

Peace officers can then patrol and take action on behalf of the owner in relation to complaints that are within their authority to investigate.

If a Peace Officer sees a property crime being committed at a property or business enrolled in the program, they would be able to make an arrest and work with the RCMP to lay appropriate charges.

Another scenario might see a Peace Officer issuing a ban on an unwanted person (neither a tenant or invited guest) and laying charges if they don't follow it.

It is modelled after a similar program in Edmonton that has been used in relation to hundreds of major public and private properties with lasting positive results for the community.

"With the cooperation of local business and property owners our goal is to see the same kind of positive outcome for our community," says Chris Clark, Manager of Enforcement Services.

Intact fire resiliency grant received

Lac La Biche County, with funding received from a grant, will be financially supporting property owners in the County with projects that enhance wildfire resiliency.

Lac La Biche County was one of 10 organizations across Canada that received grant funding from Intact Public Entities and Intact Financial Corporation. This grant offered funding for projects and programs that reduce the impacts of floods and wildfires on communities and keep people safe.

The County was approved for \$76,000 to implement the Wildfire Mitigation Incentive Program.

The Program complements existing County FireSmart programs and will provide funding to property owners in Lac La Biche County to complete FireSmart projects on their properties. This includes things like tree removal, brushing, replacement and changes to building materials, as well as other projects that reduce wildfire risk and threat on a property.

The County will be accepting applications shortly, and will release more detailed program guidelines and application materials in the near future. Watch for details on our website and social media channels.

Every business that signs up for the Business Partnership Program will receive a sticker to display outside of their business or property.

This identifies the property as a participant in the program to responding officers. It also makes everyone aware that your business has an added level of support in terms of crime prevention.

Business and property owners can join the program by filling out an electronic application form on our website: https://laclabichecounty.com/p/business-partnership-program Once submitted you will receive a confirmation email and the request will automatically be forwarded to Enforcement Services. During summer months you can also get in touch with our Street Ambassadors to assist you join the program.

Safety Code Permits keep us safe

The permitting process acts as a safety double-check

Permits are an instrumental component for protecting property owners.

Property owners, contractors, and Lac La Biche County gain value from permits by having highly trained certified professionals inspecting all work to identify potential hazards and ensure all aspects of a project meet the minimum code standards.

Lac La Biche County is an accredited municipality with Safety Codes Council, which grants us the authority to require new construction to obtain the necessary permits for the job and to ensure the work complies with all applicable regulations. Being an accredited municipality also requires us to monitor and enforce compliance for all Safety Codes disciplines.

The Inspections Group Inc. is a contract agency that Lac La Biche County has hired to review, issue and inspect all new work within the County.

It is this easy... Once your Development Permit has been issued, you can apply for all applicable Safety Code permits (building, electrical, gas, plumbing and private sewage) by visiting The Inspections Group website at the link below, or by calling their office.

Please note that it takes approximately two (2) weeks to receive your approved permit, which must be issued prior to the start of work.

Did you know... The Inspections Group Inc. can also inspect existing building, electrical, plumbing, gas and private sewage systems to ensure they meet the minimum standards. To request such an inspection, you can contact their office to complete the Fee For Service application, pay the applicable fees and schedule the inspection.

What's new... In June, The Inspections Group Inc. implemented Expedited Building Permit Forms. This allows the



Building Inspector to do a quick review of specific projects and provide a preapproval should the proposal meet the requirements. This does not dismiss the safety code regulation requirements.

Some examples of projects that fall within the expedited building permit forms are:

- Accessory Buildings under 55m² and one storey in height
- Hot Tubs
- Basement Development
- Wood Stove
- Demolition Permits
- · Mobile Home, one storey in height
- Uncovered Decks under 6 feet

Don't forget... Once your Safety Code permit has been issued, make sure you understand the conditions of approval and remember to book your inspections!

Any work that has been completed (covered) without the proper final inspections may be required to pay fees or to submit a form by a certified engineer that the work meets the minimum requirements.
