



NOTICE OF CONSTRUCTION

BEAVER HILL ROAD AND 91 AVENUE INTERSECTION IMPROVEMENT

Dear Property Owners/Residents:

As an approved Lac La Biche County construction project for 2022, Knelsen Sand & Gravel Ltd. have been contracted to provide intersection improvements to intersection geometry, traffic flow and illumination. The affected area/construction zone will be along the east side of Beaverhill Road (from 90 Avenue to 91 Avenue) and south side of 91 Avenue (from Beaverhill Road to 300 meters east). Pre-construction work will be performed in the area by Telus to migrate communication lines and FortisAlberta for streetlight relocation. Detailed maps of the project area/zone and detour route are attached.

Timeline:	May 11, 2022 to June 30, 2022 (weather dependent)
Scope of Work:	Grading, Granular Base Course and Asphalt Concrete Pavement that includes road widening, excavation, base paving, concrete sidewalk, concrete median, curb and gutter, decorative lighting installation, signalization, intersection lighting, signs, and line painting.
Hours of Work:	7:00 a.m. to 7:00 p.m. (Monday to Saturday) 9:00 a.m. to 9:00 p.m. (Sundays and Holidays, as required)

Impact to Residents and Local Traffic:

- Speed reduction, minor delays, traffic interruptions, lane closure, and construction zone detour.
- Signs and safety messages will be installed prior to the start of construction and will be monitored throughout the construction period.
- Safety will be monitored, and dust control will be addressed during construction.
- There are no planned interruptions to water, sewer or communication services.
- Follow detour signs on Beaverhill Road and 91 Avenue to safely bypass the construction zone, 91 Avenue west will remain open as one-way traffic only.

The Contractor and Wood. have committed to operating in a courteous and professional manner. Please be mindful of all installed construction signage and safety messages. Maintain a safe distance from construction work and do not enter marked, flagged or barricaded areas. Always follow traffic directions from all flagger personnel during construction operations.
