

**BYLAW 24-012
OF
LAC LA BICHE COUNTY**

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA TO AMEND BYLAW 22-012, AS AMENDED, BEING THE MUNICIPAL DEVELOPMENT PLAN OF LAC LA BICHE COUNTY.

WHEREAS Council adopted Bylaw 22-012 to be used as the Lac La Biche County Municipal Development Plan; and

WHEREAS it is deemed expedient to amend Bylaw 22-012, as set out in Section 692 of the *Municipal Government Act*, R.S.A. 2000, Chapter M 26, as amended;

NOW THEREFORE under the authority and subject to the provisions of the *Municipal Government Act*, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

Bylaw 22-012 Amendments

- 1 That Bylaw 22-012 being the Municipal Development Plan is amended as follows:
 - (a) Schedule “A” Map 3, Future Land Use – Hamlet of Lac La Biche, is amended such that Lot 1, Block 5, Plan 1222024 containing 1.92 Ha (4.76 Ac) in size more or less, be redesignated from Commercial to Institutional/Recreational as shown on Schedule ‘A’ of this Bylaw.

Severability

- 2 Each provision of this Bylaw is independent of all other provisions. If any such provision is declared invalid by a court of competent jurisdiction, all other provisions of this Bylaw will remain valid and enforceable.

Effective Date

- 3 This bylaw shall come into effect upon passing of the third reading.

THAT BYLAW 24-012 BE GIVEN FIRST READING THIS 12TH DAY OF MARCH, 2024.

THAT BYLAW 24-012 BE GIVEN SECOND READING THIS 23RD DAY OF APRIL 2024.

THAT BYLAW 24-012 BE GIVEN THIRD READING THIS 23RD DAY OF APRIL 2024.

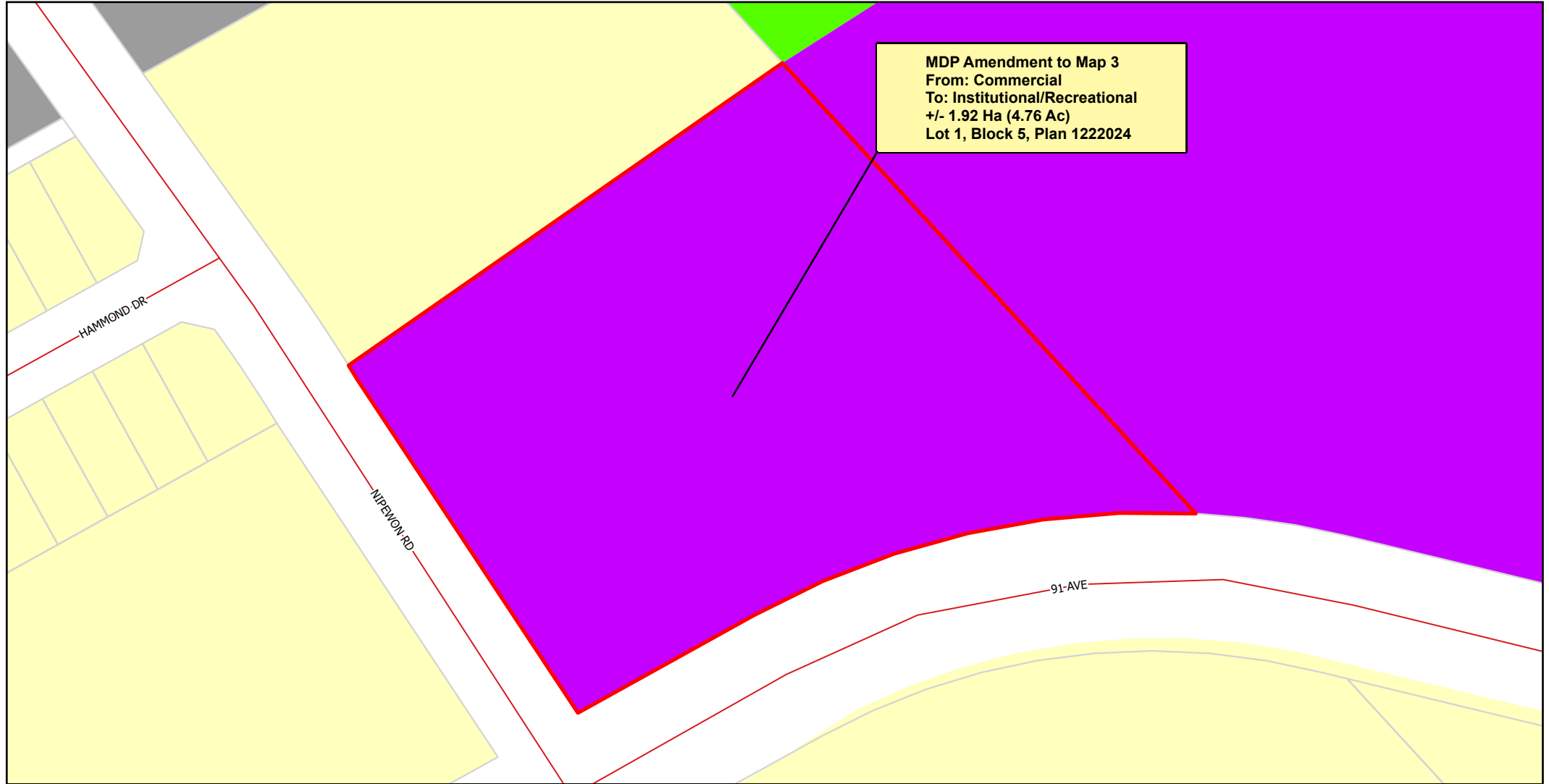

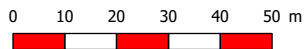
