

**BYLAW 24-018
OF
LAC LA BICHE COUNTY**

A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA TO REVISE BYLAW 22-024, BEING A ROAD CLOSURE BYLAW.

WHEREAS Council has adopted Bylaw 22-024 for the purpose of closing to public travel and disposing of portions of a public roadway;

AND WHEREAS the legal description cited in Bylaw 22-024 requires revision to enable the road closure to be registered with the Alberta Land Titles Office;

AND WHEREAS section 63 of the *Municipal Government Act*, Chapter M-26, R.S.A. 2000, as amended (“the Act”) authorizes the passing of a bylaw that makes bylaw changes, without materially affecting the bylaw in principle or substance, to bring out more clearly what is considered to be the meaning of a bylaw;

AND WHEREAS section 63 of the Act requires the Chief Administrative Officer to certify in writing that the proposed revisions were prepared in accordance with section 63 prior to first reading;

AND WHEREAS section 65 of the Act provides that a bylaw made in accordance with section 63, and the resulting revised bylaw, are deemed to have been made in accordance with all other requirements of the Act, respecting the passing and approval of those bylaws, including any requirements for advertising and public hearings;

NOW THEREFORE under the authority and subject to the provisions of the *Municipal Government Act*, and by virtue of all other powers enabling it, the Council of Lac La Biche County, duly assembled, enacts as follows:

Revisions to Bylaw 22-024

1 Bylaw 22-024 is revised by this bylaw.

2 The title of Bylaw 22-024 is deleted and replaced with:

REVISED BYLAW 22-024, A BYLAW OF LAC LA BICHE COUNTY IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL AND DISPOSING OF PORTIONS OF A PUBLIC ROADWAY IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26, R.S.A. 2000, AS AMENDED.

3 The legal description in Bylaw 22-024 is revised by deleting section 1 in its entirety and replacing it with:

ALL THAT PORTION OF PLAN 499PX LYING WITHIN AREA “A” PLAN 242 _____
ALL THAT PORTION OF PLAN 772 0980 LYING WITHIN AREA “B” PLAN 242 _____

AS IDENTIFIED IN SCHEDULE “A”, ATTACHED HERETO AND FORMING PART OF THIS BYLAW.

- 4 Bylaw 22-024 is revised by deleting Schedule "A" in its entirety and replacing it with Schedule "A" attached hereto.

Effective Date

- 5 This bylaw shall come into effect upon passing of the third reading.

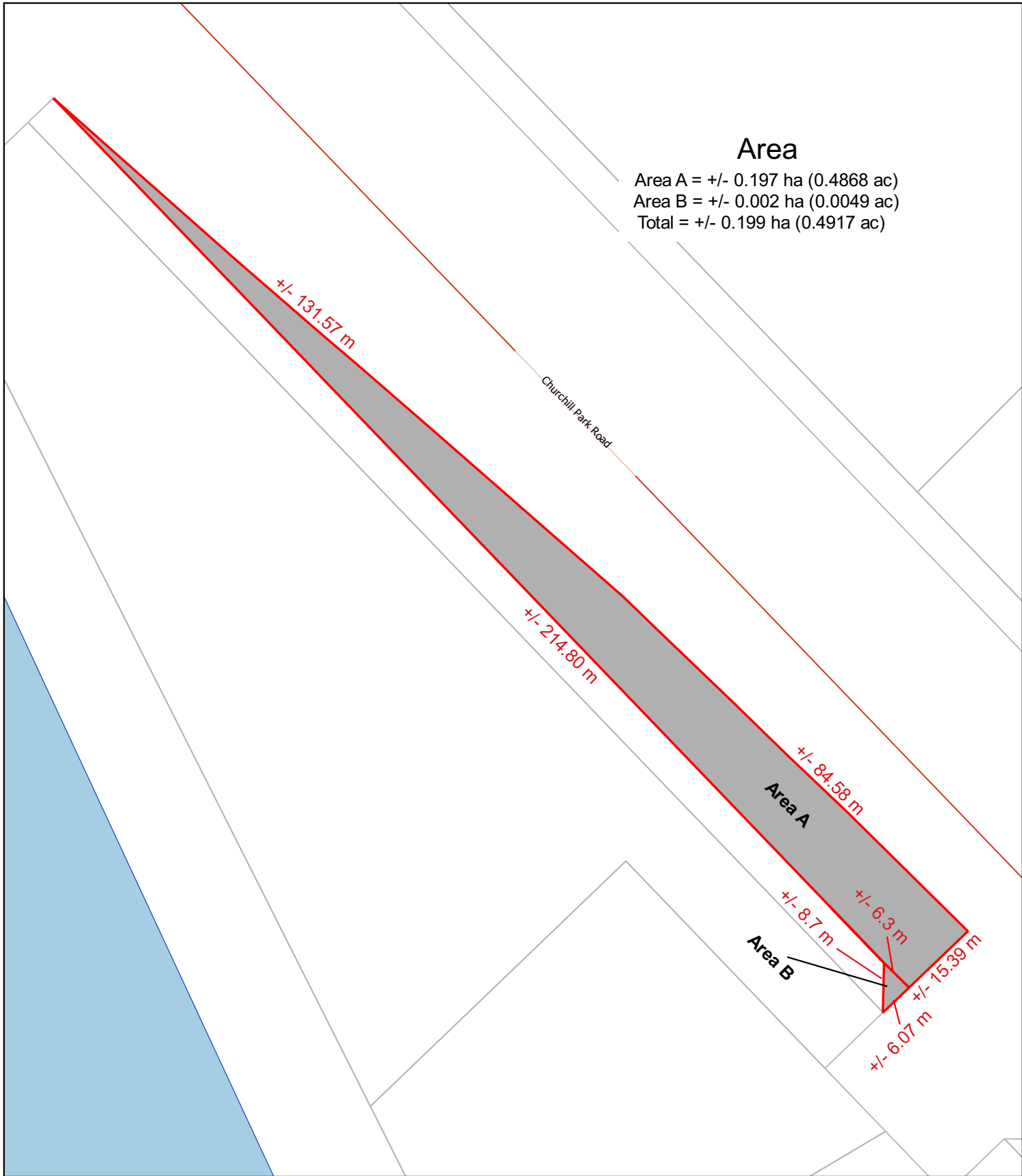
