POLICY STATEMENT:

Mayor and Council of Lac La Biche County (the County) may officially name streets and roads or sections of thereof.

1. Names proposed for roadways shall meet the following criteria:

- i) be positive in nature;
- ii) descriptive of an area;
- iii) in common use;
- iv) not used in an adjacent location within the County, and
- v) of regional significance or theme.
- 2. A road that has been already named within Lac La Biche County shall not be renamed. Proposals will only be accepted for roads that do not have a name on them already.
- 3. Roads within the downtown core of hamlets in Lac La Biche County will not be considered for road naming.
- 4. Use of personal names of living persons may not be considered.
- 5. Council may consult with the public prior to the naming or renaming of a road.
- 6. A road naming application is required when submitting a request to name a road.

PRINCIPLES:

Lac La Biche County is committed to providing a clear understanding of the expectations and responsibilities of all parties involved in requesting consideration for the formal naming of County streets and roads and ensuring that the same criteria for making decisions on the naming of streets and roads is applied in a consistent and objective manner.

GENERAL GUIDELINES:

To provide a policy for administering applications requesting the naming of County streets and roads.

DEFINITIONS:

- 1. Chief Administrative Officer (CAO) the individual appointed by Council to that position or their designate.
- 2. Road Name the approved name given to a County Street, Range Road or Township Road which shall not replace the rural address nomenclature but will complement it.

PROCEDURE:

- 1. Requests for official naming of a road name shall include a completed road naming application and directed to the Chief Administrative Officer.
- 2. An official road name will not replace the rural/urban address nomenclature but will complement it.
- 3. GIS information, official addressing and registration of roads will remain tied to the original rural/urban nomenclature.
- 4. All requests, in any case, will be subject to the approval of Council.
- 5. The CAO will include officially designated road names on editions of the County Map.
- 6. The Provincial Department of Transportation is to be contacted prior to installation of road signs to be placed adjacent to provincial highways.
- 7. A letter of support to be signed and submitted upon the submission of a road naming application. Letters of support shall be signed by the owners of the properties that are adjacent to the proposed road or street naming request. This will apply to owners of high-density housing as well but not to the individual occupants.
