Green Rebate Program open for submissions

If you're ready to reduce your water and energy consumption, making use of the Green Rebate Program could help you achieve your goals.

Put money back in your pocket each time you buy an eligible Energy Star or WaterSense certified appliance or fixture.

For your appliances to be eligible for rebate, you'll need to meet the following criteria:

- You must be a resident of Lac La Biche County.
- Your purchase must have been made between January 1, 2021, and December 31, 2021.

Visit our website to complete an application form and review the eligible appliances. Lac La Biche County wants to reward you with a \$50-\$400 rebate, plus another 10 per cent bonus for purchasing locally.

Information about Permits and Projects

Did you know that every parcel of land in Lac La Biche County belongs to a zoning category? In the Land Use Bylaw, each zoning category has specific regulations.

When you apply for a development permit, we make sure that what you are proposing follows the regulations that apply for your parcel's zone.

If you are planning a project, big or small, please contact the Planning and Development Department to confirm what permits or approvals that may be required. A development permit must be issued prior to the work starting, or the application is subject to a double fee penalty.

Lac La Biche County has created simplified development brochures to share information and answer frequently asked questions. These can be found on our website at: www.laclabichecounty.com/our-services/planning-development.

When a Development Permit is not required:

- Accessory buildings smaller than 110 ft² in size and under 8.0 ft in height
- New deck construction that is under 2.0 ft above grade
- Temporary fabric structures (such as: carports and portable tent shelters)
- Fence construction, or other means of yard enclosure that is 2.0 m (6.6 ft) or less in the side and rear yard and 1.0 m (3.3 ft) in the front yard.

- Maintenance or repairs, provided that such work does not include structural alterations or a change in use
- Mobile food service unit (example: food truck)
- Above ground pools and play equipment

**To view the full list, please refer to Section D1.3 of our Land Use Bylaw or contact a Development Officer.*

NOTE: If the proposed accessory building is on skids, a development permit is still required unless it meets the requirements noted above.

A change in use may trigger the requirement of both a development and building permit. For example: if you are converting your residence into a salon or changing an existing commercial building to residential use, then a development permit and building permit are required.

In addition to the development permit, your project may also require Safety Code Permits. These include, but are not limited to: Building, Electrical, Plumbing, Gas and Private Sewage permits. The Inspections Group is the County's contracted services provider who approves and inspects all projects to ensure compliance with the applicable Provincial legislation.

As of February 1, 2020, The Inspections Group Inc. processes all Safety Code applications and permit fees. Applications can be found on their website at: www.inspectionsgroup.com, or by calling their office toll free at: 1-866-554-5048.

Information about Municipal Addressing

Lac La Biche County is currently reviewing and updating Municipal Address Bylaw 06-023.

The purpose of this Bylaw is to improve the safety, health and welfare of people and the protection of property by providing a consistent addressing system that emergency service providers can use.

In 2008, the County received a grant to install municipal address signs on all parcels that had existing development. Moving forward, every person who obtains a development permit for development in which an address has not been previously assigned and installed is responsible for purchasing and installing an address sign.

Did you know that there are fines associated with failing to post or display a municipal address sign, and for removing an existing one? Signage that is not displayed accordingly can incur a fine in the amount of \$100 as per Bylaw 06-023.

The first stage of this project required staff to compare homeowners' signs with the County's database in the hamlets and along our rural roads. It took about 2 months for staff to verify approximately 5,500 properties.

Now that the information has been compiled, landowners can expect to receive a letter which confirms their municipal address. As part of this project, landowners will also be receiving a magnet which they can note their address and display in their home as a quick reference.


