GENERAL INFORMATION:	
Application Forms:	Must be complete and include all attachments. See below and Part 5 for specific requirements. Submit as soon as possible as candidates will be assigned on a first-come-first-served basis.
Course Fees:	<p>The fee for the course is \$7500.00 + GST (This includes accommodations) The fee for the course without accommodation is \$5800.00 + GST</p> <p><i>Applicants:</i> An invoice will be sent to the Authorized Employer one month before the course start date for payment. The Government of Alberta does not subsidize this training program.</p>
Medical Consent Form:	Must accompany the application. This form may be one that the authorized employer uses for employment or a doctor's physical assessment. Your doctor must sign this form declaring your fitness to participate in this course and is valid within six months of the course start date. <i>(This is not the same as a PARE or COPAT certificate.)</i>
PARE / COPAT Tests:	Must accompany the application. Valid for six months only. If PARE COPAT expires before the first day of class, a new PARE test result must be submitted two weeks before the course date.
Accommodations:	Accommodations are provided to those that require them. However, the accommodations provided will be shared four-bedroom townhouses. A kitchen is provided in all units, no dishes or pots/pans provided Fee: \$1700.00 + GST (See course fees above)
Confirmation of Enrollment:	An acceptance e-mail will be sent upon receipt of your application.
Reserved Spaces:	Employers may continue to reserve seats as needed. However, the employer may be liable for 50% of the course fee should they cancel the reservation for any reason within 15 business days of the course commencement. Where a waitlist exists and Lac La Biche County Enforcement Services can fill the cancelled seat, no charges will apply.
Cancellations and withdrawals:	<p>Cancellations and withdrawals from agencies less than 15 business days before the course start date or within the first three (3) weeks of the course will be required to pay 50% of the course fee.</p> <p>Withdrawals after week 3 of the course will be required to pay the full course fee.</p>
Course Cancellation:	If insufficient applications are received, the course may be <u>cancelled</u> . Applicants will receive notice two weeks before the commencement date and will automatically be enrolled in the next scheduled course date.
